## **APPROVAL OF AGENDA & PREVIOUS MEETING OUTCOMES**

## **TREASURER'S REPORT**

- **Account balances:** Checking \$1,215.12; Savings \$223.46; Petty cash \$169.29 = \$1,607.87
- **Expenses to reimburse P. Miller\*:** Bluehost \$17.99 + Zoom \$127.93 = \$143.92\*;
- **Upcoming Expenses:** 3 mo. Coordinator \$405; Newsletter/postcard \$600/\$1,000; CDBG Grant has been totally used: \$2889. A postcard for name change final vote will need to be printed. LMH is having issues with their color printer (Free to PNA); UPS has given a bid of \$500; Minute Man to provide bid (**P. Miller**); School district is a possibility (**S. Heiman**). Postage is additional; **D. Unekis** to save first Postcard to Google folder.

## **UPDATES & REPORTS**

- **Possible Future Neighborhood Funding/Engagement Opportunities:** In the absence of the CDBG grant, the City is planning to fund neighborhoods. 2021 approx. \$2,000 (can be used retroactively) to fund the 4 neighborhoods that previously received CDBG; 2022 fund the 4 neighborhoods at the current amount; 2023 TBD but funding anticipated to be broader than the 4 neighborhoods. **P. Miller** is leading a group to develop a fair and equitable proposal for neighborhoods to qualify for funds and report fund usage.
- **President's Report:** 1) Letter/site plan for the Car Quest location (1830 W. 6<sup>th</sup>) was reviewed. Generally, PNA supports it. **S. Heiman** to find out about ingress/egress, bike parking and ADA compliance relative to safety. 2) **S. Heiman** to attend Virtual Open House May 20 for DT master plan; he is on the Master Plan Steering Committee, which has its next meeting May 27. 3) PNA received a letter from Douglas County Planning Commission re: McCray Lumber right-of-way change. PNA has no issues with it. DCPC will discuss it June 1. **S. Heiman** to introduce himself to McCray Lumber to let them know the neighborhood does not object and hopefully lay the groundwork for participation in neighborhood events by McCray.
- **Results of renaming PNA:** Received 316 votes. The following 4 names were top vote getters: Pinkney (named after William with no "c") Woody Park, Cameron's Woods and Riverbend. Vote for final name will be June 1-30 (if printing allows for this timing). Signage in Constant Park and at Hugh Cameron placard locations needs to be updated. Neighborhood to be scoured for additional sign changes. No specific timeline for transitioning the name has been defined but one year to 18 months is anticipated. Several items will need to be changed including developing a new logo, which could possibly be a contest. **K. Heck** to send a list of name change items she has. A letter re: the final name will need to be sent to Pinckney school at the appropriate time.
- **LAN Report.** Nothing significant was reported. Discussion centered on CDBG elimination.
- **Vaccination Clinics.** Moved to LMH; Community Bldg. has one Sun., May 16, 2-4 p.m.
- **Community Garden.** Participation event today, May 15, 4:30-6:30 p.m. for planting and harvesting. There will be an event for Container gardening on May 22.

## **BUSINESS ITEMS**

- **PNA Meeting time.** New timing to be considered. Keep location consistent: Health Dept. (Charlie Bryan) or USD facilities (Julie Boyle) to be considered. A poll to be developed (**S. Heiman and E. Gardner**). Hearing is challenging during a hybrid event. A good microphone is essential. May be able to get a used one.
- **Outdoor Candidate Forum.** There is interest in PNA hosting one, perhaps with OWL, in June. PNA as an organization cannot endorse any candidate.
- **Community Service event.** There is strong desire to do a service event. In the poll noted above, ask if any neighbors are in need and PNA can connect them to the correct resources. A fire at the apartment complex at 5<sup>th</sup> & Florida displaced 10 families. **S. Heiman** to contact apt. manager to find out needs of the families.
- **Picnic.** No decision was made. Maceli's provided the event coordinator's name for box lunch possibility.
- **Safer Neighborhood Speeds Campaign.** Has had a positive effect in Pinckney. Pilot survey is open.
