TREASURER'S REPORT

- **Account balances:** Checking \$531.81; Savings \$223.55; Petty cash \$159.29.
- **Duns #/SAM Registration.** PNA no longer needs a SAM Registration and a Duns number to be able to receive funds from the city (were required for CDBG grant funds).
- **Upcoming expenses:** Coordinator payment and Bluehost domain for Pinkney address with a "c". The Board supports spending \$18.99 for a one-year extension of the domain with a "c".

BUSINESS ITEMS

Guest Connie Fiorella-Fitzpatrick gave an overview of the "Peoples Markets Program" which grew out of the Office of Sustainability. This new pilot program combines outdoor public art and ethnic neighborhood markets. Pinkney has two ethnic markets: Asian market (F Mart) at 6th & Colorado and the African Caribbean Market at 1530 W. 6th. C. Fiorella Fitzpatrick is seeking a letter of support from PNA for a public art mural to be painted on each building by artists Emmi Murao (Asian market) and Kamela Eaton (African Caribbean Market).

P. Miller made a motion for PNA to support this project in PNA; 2nd by J. Spence. Voice/hand raise vote. Motion carries. S. Heiman to author the letter.

REPORTS
