TREASURER'S REPORT

- **Account balances:** Checking \$323.06; Savings \$223.55; Petty cash \$164.29.

BUSINESS ITEMS

Guest F. Lavergne provided an overview of the proposed new transit routes which will affect neighborhoods. The redesign phase is underway through Aug. 2022; phase 2 will go through Jan. 2023. The pilot phase will provide free transportation. Some of the new features include two-way service on Route 3 and a welcoming new hub with resources for riders. A survey about the proposed routes is open until the end of April on Lawrence Listens. Issue that are still pending include ADA, schedules and time timetables. There will be training on all routes and on new app, "track your bus".

- **LAN Report.** 2050 Transportation Steering Committee has extended its efforts from 2020 to 2050.

Motion carries.* Volunteers include P. Miller, K. Heck, J. Spence, and J. Unekis. P. Miller to reserve the shelter for June 18.
- **Parks Clean Up.** PNA will concentrate on Clinton Park for a cleanup immediately following the May PNA meeting, on May 21. J. Spence to notify the city and secure trash bags and gloves. E. Gardner to let the city know about how their mowing practices, i.e. mowing trash, is causing trash spread in our parks. *Motion to hold a parks cleanup in Clinton Park by E. Gardner; 2nd by K. Heck. Hand-raise/voice vote. Motion carries.*

- **City sidewalk assessment** seems to have begun in Pinkney. There is a map on the city's website and the deadline given to some PNA residents is to have their sidewalks repaired by the end of July.
