TREASURER'S REPORT

- Account balances. Checking \$282.14; Savings \$223.73; Petty cash \$194.21
- Upcoming expenses. Coordinator fees: May, June, July; plus, reimbursements due to P. Miller for expenses personally paid for domain name, zoom, postcard printing and postage in the amount of \$884.94.
- Grant funds. All neighborhood associations funding from the city has been delayed until mid-July.

GUEST PRESENTATIONS

- Brian Bradfield, LMH: B. Bradfield provided an update via zoom for several LMH activities:
 - 2 houses that are in disrepair leased by LMH to Family Promise are being demolished: 505 Maine (sustained fire damage); and 509 Missouri. Timing is 60-90 days. Families that lived there were relocated. [Later during the meeting, there were comments that more effort should be put into renovating these houses due to the affordable housing crisis in the community.]
 - Reed Medical services and TFC Family Practice have been relocated to the 1st floor of Ortho Kansas and a walk-in clinic has been added by LMH. The. Reed building is on the market for lease.
 - All aspects of the Treatment and Recovery Center are open. LMH provides to them facility management, nutritional services and lab services.
 - The Oncology Center is being renovated including adding a new two-story entrance and bringing in radiology; renovation should be completed by Oct.

REPORTS

- **President's Report.** Valet service at LMH, which was discontinued during the past year, will re-start by the end of July. It will be managed by the LMH Volunteer Services.
- LAN Report. The expansion of the KU football stadium and surrounding area in the Oread neighborhood has that neighborhood concerned and they have expressed a strong need to be engaged as the university moves forward.
- **Community Children's Center**. It is nearly ready for occupancy in the Medical Arts Building. In addition to state-of -the-art early childhood education, it will provide overnight and weekend services.

BUSINESS ITEMS

- **Pallet Village Update**. There have not been any Task Force meetings held to-date. PNA has not been kept informed of the delays, obstacles or progress of the village (except through the general media) as promised. A solution to this lack of communication is to ask the city to give an update to the neighborhood at each monthly meeting. S. Heiman to request. PNA should receive a copy of the new RFP prior to its release.
- **Pancake Brunch**. Final details were discussed: S. Heiman will pick up the griddle, propane and utensils from Anderson. K. Heck and P. Miller to shop on June 22. A spreadsheet of tasks has been shared. Cash donations will be taken for the brunch; canned goods and cash for Heartland Community Center.
- **PNA representative on Lawrence Loop Steering Committee**. The time commitment is 3 to 4 meetings for a total of 6 to 10 hours. L. Lange to consider representing PNA. E. Gardner to post on social if L. Lange is unable to participate.
