REPORTS

- President's Report.
 - 1. President Heiman attended the Lawrence Arts Commission meeting to show support for the ethnic grocery store outdoor mural project. There was some discussion that the timeline to paint the mural was not realistic, but the Commission gave its approval with the understanding that the timeline may need to be lengthened.
 - 2. LMH Update Conversation with CEO Russ Johnson. Reed Medical will move into 6th & Maine building. Undetermined use for Reed. Children's Learning Center is moving into Medical Arts Building. LMH owns the buildings on Maine. They will be repurposed, ideally most for affordable housing. LMH is committed to also making Woody Park (which will be relocated) and Sandra Shaw more welcoming.
 - 3. Lawrence Loop nearly complete.
- LAN Report. Bert Nash is proposing 20 to 24 affordable housing units in Downtown Lawrence in variety of models, i.e. above commercial space, free standing. Breaking ground is desired for fall 2023. Funding, planning and locations need to be determined.
- **Signage Committee**. The city contacted Chair Heck and has moved the signage planning to April 2023. The City is undergoing a rebrand process which could affect signs. PNA hopes to be first in line!
