### PRESIDENT'S REPORT

• **Traffic Calming Devices.** R. Stumblingbear attended a City Open House on calming devices and three PNA sites were noted: 6<sup>th</sup> to Burcham Park on Indiana; W. 4<sup>th</sup> Indiana to Maine; and Wisconsin 2<sup>nd</sup> to 4<sup>th</sup>. The City will monitor for speed, traffic volume, crashes, sidewalks, school/pedestrian crossings. PNA to be contacted if any locations are selected.

### **OTHER REPORTS**

- LAN. At the recent LAN meeting, neighborhoods gave reports including one from OWL seeking support. **OWL** (new agenda item) is authoring a letter to the City Commission to suggest amendments to the land development code requesting a reduction to 3 unrelated people and seeks PNA support. PNA made a motion to support the Planning Commission's recommendation to the City of 3 unrelated people for maximum occupancy: *Motion by P. Englehart, 2<sup>nd</sup> by K. Heck.* Hand-raise vote. Motion carries. P. Miller to write a letter stating PNA's position.
- The Village. A meeting of the City management team overseeing the Village was held. Reported at that meeting was that there have not been complaints regarding Village residents. PNA to invite the Homeless management team to attend its April meeting to give a progress report on its plans to remove and clean up the homeless camp in Sandra J. Shaw Park. Trash is extensive there.
- City Capital Improvement Plan. Place this on PNA's Jan. 2026 calendar to start developing content to submit.

#### **NEW BUSINESS**

- Change of Zoning. There has been a request to change zoning from single family to RS7 to accommodate a 24-unit apartment complex at 3<sup>rd</sup> & Michigan/3<sup>rd</sup> & Florida. A motion was made: *PNA is to write a letter to the City Commission asking them to deny the proposed rezoning request. Motion by P. Englehart. 2<sup>nd</sup> by K. Heck. Voice vote. Motion carries. R. Stumblingbear to author letter by March 23<sup>rd</sup>. A post will be placed on PNA's social media to inform neighbors about the proposed zoning change.*
- Request from Candidates to present to PNA. PNA will invite all City Commission candidates to attend its summer event (June 21) to mingle with neighbors; no verbal presentations to the attendees will be allowed but campaign materials are acceptable.
- **PNA Summer Event.** A Motion was made to hold a Potluck Brunch on June 21<sup>st</sup>, 10 a.m. to noon. *Motion by P. Miller*, 2<sup>nd</sup> by R. Stumblingbear. Voice vote. Motion carries.
