REVIEW OF AGENDA AND ADDITIONS - There were no additions to the Agenda.

APPROVAL OF PREVIOUS MEETING OUTCOMES

GUEST PRESENTATION— JONATHAN SMITH, DIR., LAWRENCE-DOUGLAS COUNTY PUBLIC HEALTH

The agency offers 10 public health services and is all encompassing. Some of these services include weekly tracking and posting of flu, norovirus, RSV, Covid cases, emergency preparedness, environmental health, childcare licensing, clinic services, WIC (at-risk of funding cuts), and family support programs. Volunteers are needed at weekend public health events.

TREASURER'S REPORT

- **Account balances.** Checking \$1,006.77; Savings \$126.67; Petty cash \$238.65.
- **Upcoming expenses:** Coordinator fees; Summer event postcard; Bluehost, Zoom annual fees.
- **City Funding has been eliminated.** PNA will not receive any funding from the City moving forward, causing hardship for PNA. There was discussion about expenses that PNA can cut. E. Riggs will finish up website cleanup and communication through May, but will not be funded for the future. *A Motion was made to not renew the Zoom subscription by P. Miller, 2nd by R. Stumblingbear. Voice vote. Motion carries.* PNA will investigate free/less expensive meeting services or use free Zoom links consecutively. Fundraising opportunities will be investigated. Donations will be encouraged via PNA's website and at the picnic brunch.

PRESIDENT'S REPORT

- **LMH Cancer Center grand opening is June 19.**

OTHER REPORTS

- **LAN.** The permit parking program will enter a pilot period Aug. to Nov. Data will be collected and community conversations will take place.

NEW BUSINESS

- **Potential Guest Presentations for Future Meetings.** Several businesses were identified including Tableview Farm; Community Connections; Treatment and Recovery Center; a farewell to honor Russ Johnson, LMH CEO, for his support of PNA as he retires from LMH (invite to July meeting); Brad Harrell (permit parking program) and Courtney Masterson, Native Lands, LLC.
- **PNA Summer Event.** The Clinton Park shelter has been reserved for June 21st, 10 – 3 for the picnic brunch. A postcard needs to be developed and mailed at the end of May. Yard signs need to be updated and placed. Activities for the kids need to be planned. All City Commission candidates will be invited to attend and bring literature. Health Dept. will be invited and encouraged to bring free Covid tests. PNA selected Heartland as its charity to receive donations during the brunch (cash ++). Need to route the brunch checklist. (P. Miller).
- **Result of Zoning at 3rd and Florida to Michigan.** Because the County Commission was split on their vote to change zoning, the City Commission will vote on May 6 (or possibly later). A simple majority is needed.
- **Burcham Park Homeless Camp.** The City “is working on it.” PNA to monitor; also Everygy is donating land to extend the Lawrence Loop, which will abut Burcham Park. PNA to monitor.

A motion to adjourn was made by P. Miller. 2nd by P. Englehart. Voice vote. Motion carries.
